

## Smart Update (Consent Agenda) For the Meeting of WRPCPC on November 18, 2016

Please note that any member has the right to “pull” an item from the Consent Agenda and add it to the regular agenda for discussion, comment or clarification. Consent agendas are published on the Council’s website [www.preventingcrime.ca](http://www.preventingcrime.ca) along with approved minutes. Consent Agendas are selective, not comprehensive. Whenever possible, Consent Agenda items will fall under the directions of the current strategic plan. The template reflects Smart on Crime 2015-2018 plan’s key approaches to accomplish three overarching Council directions:

- Youth: Unleashing the Potential of ALL Youth
- Neighbourhoods: Building Local Capacity for Change
- Smart on Crime: Advancing the Momentum

### Expand Reach through Understanding and Engagement

- The Connected School Award was presented to Sir Edgar Bauer School (K-8) on October 31 and MacGregor Public School (7-8) on Nov. 17
- WRPCPC was invited to be part of a “Tug of Help” demonstration at a Bullying Prevention Assembly at Elizabeth Ziegler P.S. in Kitchener on Nov. 10 to kick off their [WITS LEAD program](#)
- WRPCPC was consulted regarding the initial draft of the City of Kitchener neighbourhood strategy recommendations. WRPCPC provided feedback based on a review of safety audits and neighbourhood-based crime prevention literature. In their current form, the recommendations address crime prevention and safety through fostering of social connectedness, belonging and place-making. While a recommendation relating to safety audits or similar undertakings is not included in the first draft, City of Kitchener is interested in discussing the idea further and potentially including it in the next draft.



## Base Change in Good Evidence and Innovation

- Formative work is underway for both the **Historical Analysis of WRPCPC** project being done by Conestoga College and the **Smart on Crime Evaluation** being done by Laurier's Centre for Community Research, Learning and Action. WRPCPC staff have provided project teams with reference documents/resources as well as input into planning. First set of deliverables is scheduled for mid-December.
- WRPCPC staff participated in the first **Community Wellness Initiative (CWI)** Forum. The event was attended by representatives from organizations (both government and non-government) across the region and it served to raise awareness of CWI and related concepts (i.e. social determinants of health/wellbeing, collective impact), gauge interest in CWI, as well as start the conversation about working together with a common focus. In addition, WRPCPC has been involved in a discussion among various community stakeholders about the possibility of implementing a coordinated citizen survey for Waterloo region and has continued to be involved in CWI's measurement and monitoring work group, which is tasked with developing a framework and related indicators for measuring community wellness in Waterloo Region.
- The Violence Prevention Committee (VPC) has developed a framework and strategy for collecting information from a variety of community organizations on service volumes related to interpersonal violence in Waterloo Region and expects to report to Council on findings in early 2017. Staff has also been meeting with organizations such as the Domestic Assault Review Team to discuss the VPC mandate of increasing engagement in the prevention of interpersonal violence through the monitoring and reporting on interpersonal violence in Waterloo Region.

## Lead Side by Side: Leverage Dynamic Partnerships

- WRPCPC staff attended a federal budget consultation hosted by Bryan May, MP Cambridge and contributed a written submission.
- All meetings with **MPs and MPPs** have now been completed and a summary overview is attached.


## Community Corner:
