## 6. September 13, 2019 WRCPC Retreat and Notes:

At the September 13, 2019 Retreat the Waterloo Region Crime Prevention Council (WRCPC) participated in a Circle to share their thoughts about the history and the work of the WRCPC and its future relationship between the Well-being Waterloo Region and WRCPC as the Design Team continues the process of developing a concept outlining that relationship. During the circle, all WRCPC members were provided with the opportunity to share their reflections to date, and for the future. Shayne Turner asked the WRCPC members that the notes and comments from the Circle exercise remain confidential.

The WRCPC membership reviewed the confidential notes from the Circle and were provided with the opportunity to provide further reflections and comments.

Shayne Turner shared the importance, during the transitional process, that the Council table continue to be a safe and comfortable atmosphere to express thoughts and comments without apprehension.

Shayne shared with Council that he meets with the Regional CAO, Mike Murray periodically, and that the CAO is aware of the work and history of Council as is Regional Council. He assured Council that the Design Team's concept development process is not being driven by Regional Council or the Regional Administration.

WRCPC representatives on the Design Team assured the Council that the Design Team is fully aware of the history, the work of the Council, the positions of Council regarding the leadership and staff, and the importance of the WRCPC mandates: Justice and Upstream Approaches along with the concerns about fatigue and confusion related to the process. Further comments, concerns and current positions of Council will continue to be taken back to the Design Team for reflection and consideration.

The next meeting of the Design Team is on November 12, 2019. The Team will continue the process of developing a concept outlining a new relationship between the WWR and WRCPC. A concept proposal will come forward to the WRCPC for review ahead of its next meeting in December 2019 or January 2020.

# 8. Approval of the Youth Engagement Strategy Terms of Reference Ad Hoc Working Group:

The draft Youth Engagement Strategy Terms of Reference to guide the ad hoc working group of the WRCPC was brought forward to the WRCPC for approval.

Michael Parkinson shared that the Terms of Reference were developed over the summer by a small working group of people that included Mark Pancer, Janice Ouellette, Courtney Didier, Kelly Anthony, Kathy Payette, Joe-Ann McComb and Heather Melo, formally staff with the City of Cambridge.

The draft Terms of Reference include a Mission and Vision statement, standard operating procedures and the ad hoc committee's relationship to Council.

The draft Mission is "To create a Youth Engagement Strategy with recommendations addressing barriers to equity to youth in Waterloo region including youth farthest from opportunity".

The draft Vision, "Healthy, thriving, engaged youth and associated caregivers" is very broad and may be refined in 2020.

Upstream approaches are important. It is equally important to be intentional about opportunities to improve systems and structures affecting the well-being of youth farthest from opportunities.

Michael shared that it has been difficult to secure funding for the Youth Reference Group, a foundational element of the Strategy, and for the scoping review of the

hybridized Icelandic Model. Without funding, the YES working group will be limited and will depend solely on limited staff resources.

The Ontario government has made funding available for municipalities that have opted in to host retail cannabis dispensaries. Approximately 1.6 million has flowed into the region. The Region of Waterloo received half the funding and area municipalities divided up the other half. The guidelines from the Ontario government highlight implementation costs related to enforcement, education and policy. Within the policy there may be an opportunity for funding. Michael and Shayne Turner will have a further conversation about the possibility of funding.

The next step for the Youth Engagement Strategy is to discuss the expansion of the working group.

Responding to a question about the connection between the YES and the Children and Youth Planning Table, Michael indicated that, similar to the Smart Cities initiative, their focus differs from WR YES but opportunities for alignment may yet materialize. The WR YES is particularly in addressing issues hindering the health and well-being of youth farthest from opportunities.
