7. Approval of the Consent Agenda: Information (Up) Stream Update:

The Consent Agenda has been reformatted to reflect the new strategic directions. Council was asked to provide any feedback concerning the new format and content.

8. Standing Items:

a. Regional Councillor Update:

Tom Galloway shared that the COVID-19 vaccination roll out in the Region's hotspot is going well. Those involved at the clinics are going door to door to make individuals aware that the opportunity for vaccination exists in the designated areas.

All elected members in the Region of Waterloo are participating in a four-part Reconciliation training with Dr. Darren Thomas Lecturer, Indigenous Studies Wilfrid Laurier.

b. Regional Liaison Update:

Arran Rowles shared that the Provincial Ministries are in the midst of a transformation of the social assistance program. The province is looking to co-design the system, and the Region of Waterloo has received direction from the Province that four consultations will be held from now to December 2021. One consultation will be held with community partners Ontario Works and Ontario Disability Support Program and community with Ontario Disability Support Program so that there will not be any duplication. The community feedback session will most likely be held in the summer.

Homelessness to Housing Stability Strategy is continuing to work internally and externally with the House of Friendship to bring back Region of Waterloo community members back that are currently in temporary housing in the City of Guelph. Presently, there are no homeless persons in the isolation spaces.

c. Anti-Racism Working Group Update:

Lu Roberts shared that the Anti-Racism Group is strong this year and has worked on a contextual statement for the strategic plan to put the vision into context. The group is also providing input into the glossary of terms available on www.preventingcrime.ca that will act as a companion to the Strategic Plan. It will be a living document. Please let Lu Roberts or Deb Bergey know if you are interested in joining the Anti-Racism Group.

A question was asked about consulting with Indigenous groups regarding the GCI students advocating for a Kitchener Street name change. Lu Roberts indicated that she is part of the Indigenous Advisory group at the WRDSB and is aware of the advocacy from GCI students. It is difficult to know if the many indigenous groups in the community have been consulted. Myeengun Henry encouraged ongoing advocacy efforts so as not to discourage advocacy.

9. Final Draft Strategic Plan for Approval:

Included in the WRCPC Strategic Plan will be the addition of the following documents: The Contextual Statement, to complement the Vision Statement, and the Glossary of Terms (key definitions). This document will live on the www.preventingcrime.ca website with a link to the Strategic Plan. The Anti-Racism group with staff support, Shama Saleh, have assisted in the development of these two documents. The key definitions are in the process of being developed and will be shared with the WRCPC when completed.

In addition, incorporated in the Contextual Statement, as part of the Strategic Plan, will be the concepts of Restorative Justice, Transformative Justice, Upstream, and Downstream approaches paired with concretes examples. This is still to be finalized.

Lu Roberts shared the following Contextual Statement for WRCPC to approve in principle:

'We acknowledge that intersecting systems of domination such as white supremacy, colonialism, capitalism, patriarchy and ableism deny many in our community access to safe, equitable, and just opportunities. Because of these systemic harms, our vision is not easily attained and will require deep structural transformation. We commit to engaging in transformational work until our vision is fulfilled.'

During the development of the Contextual Statement, the words 'such as' was used in an effort to name some of the systems of domination.

The term 'intersecting' was included in the statement recognizing that some of the systems of domination can influence one another.

Lu shared that the following statement weaved intersectionality into everything, the Council (or we) do: 'Everything the Council does has to centre intersectional, anti-racist, anti-colonial, equity lenses. This should weave through all undertakings of the Council.'

The focus of the Anti-Racism group is that it is considering these intersections throughout everything e.g. Speaker Series, Reports, and Research etc.

A Council member recommended that the Anti-Racism group prepare a strategy response to address groups in the community that may query the language in this statement.

This suggestion was added to the agenda of the Anti Racism working group.

12. UPstream Speaker Series Update:

Julie Thompson provided an update about the WRCPC <u>UPstream Speaker Series</u>. The virtual seminars will be held during the month of June 2021. All the webinars will be recorded, edited, and available on the WRCPC website.

The first virtual event called **(Re)Think Crime...because it isn't real** will be held on June 10, 2021, starting at 6:30 p.m. Jessica Hutchison will be presenting about the concept of crime and criminalization. What is crime and why are certain people seen as 'criminal'? The registration is open but the event has yet to be advertised.

The second virtual event called, **(Re)Think Our Stories: The reality of structural violence** will include those with lived experience of structural violence. The staff would like to run the series event two to three times a year with different panelists. The key messages and goals would stay the same but include different panelists that have experienced structural violence.

The third virtual event **(Re)Think Our Organizations: How we harm when we mean to help** focuses on how social organizations and systems cause harm. Panelists include Teneile Warren, an antiracism educator and equity consultant, and Karen Spencer, Executive Director of Family and Children's Services of Waterloo Region. A third panelist is to be announced.

The last event **(Re)Think "Crime" Prevention through an upstream lens** focuses on changes to systems that are at the root of suffering while preventing the harms from occurring in the first place. The panelists include Alfgeir Kristjansson Associate Professor of Public Health at West Virginia University Janice Ouellette, Supervisor of Children, and Youth Services at the City of Kitchener, Lana Mills, Associate Professor, and Chair in Prevention of Domestic Violence at the Faculty of Social Work, University of Calgary.

Julie asked the WRCPC to promote the event. An information email and flyer will be sent to Council members for them to forward to their networks. The Council members were also encouraged to share the event through social media. Staff will develop a few social media posts for Council members to share. Council members were encouraged to attend.

Julie asked the Council members for any further ideas that they may have that would fit within the upstream theme. Julie and Abbi would be willing to support Council members, as the talent coordinators, to develop a webinar specific to the topic.

Julie and Abbi Longmire are working with a communication-consulting group to develop the branding for the **UPstream Speaker Series**.

13. Communications & Engagement Plan & Working Group:

a. Relaunching of the THINK campaign, Social Media Plan:

Abbi Longmire, the Communications Community Engagement Coordinator provided a communications update, which included social media, the WRCPC website, Constant Contact newsletter and current campaigns of the Council.

WRCPC has four different social media channels: LinkedIn, Instagram, Facebook, and Twitter channel. Abbi is gathering communication analytics on all channels.

A section of the WRCPC website, called 'Updates', has been added to the website. The page will host the news and blogs. There is a desire to incorporate WRCPC member blogs. Please let Abbi know if there is an idea or an interest in writing a blog.

Abbi is currently involved in the WRCPC THINK campaign that began on May 6, 2021, with a focus on anti-bullying awareness, and ending on Sunday, May 16, 2021, with a focus on togetherness.

The WRCPC collaborated with the Princess Cinemas by renting its marquee for THINK campaign messaging.

Following that portion of the campaign, the Instagram contest began for those under the age of thirty. This was in partnership with four local organizations, Kitchener Waterloo Multicultural Centre youth, Princess Cinema and Playhouse Cinema, the contest was posted on their website. This provided the potential opportunity of thirty thousand followers. Twelve different businesses supplied prizes for the contest.

In addition, Abbi has been conducting 5 days of virtual tips on all WRCPC channels with each day focusing on each different element of the THINK campaign (think before you comment):

Is it True?

Is it **H**elpful?

Is it Inspiring?

Is it **N**ecessary?

Is it Kind?

Abbi asked Council members to help promote the messaging on social media.

14. Executive Director Update:

a. Community Engagement Coordinator Update:

Shama Saleh, the new Community Engagement Coordinator, is currently working to support the Anti-Racism work and the Youth Engagement Strategy work.

Shama shared that much of her past work has been with youth led non-profit organizations and is open to have discussions with Council members interested in this type of work. Shama will provide an update about the work of Council at a future meeting.

b. Video Conferencing Meetings Update:

The Region of Waterloo is in the midst of migrating from Zoom to MS Teams. Deb Bergey will keep the WRCPC members updated as to whether or not this will effect CPC meetings, and working group meetings going forward.

c. Transition Team:

Peter Ringrose shared that as the WRCPC starts to move forward towards a new model, the WRCPC needs to have discussions about all the various issues and ideas that are involved within the transition. There is a recommendation to create a transition steering team to investigate the various options as the Council moves forward.

Peter Ringrose moved that the WRCPC form a transition steering team to help prepare the way towards the new model of the justice centre.

Richard Eibach shared that in addition to the transition steering team, there have been discussions about creating a partnership team to focus on partnership issues, draw on all the WRCPC's knowledge, experience, and perspectives, and to bring as many of the Council members into the conversation for the next steps and processes going forward.
